It is no secret that pending city-wide budget cuts will have a major impact on our neighborhoods and community programs and services. With a proposed 18% cut in city funding, the Neighborhoods Small Grants Program is one that will be discontinued. This program has offered direct funding for volunteer-driven community projects such as: gardens, helping seniors, tutoring, tree planting, community dialogues, etc.

In response, the Northeast Coalition is launching a new Community-Building Fund dedicated to continuing the Neighborhoods Small Grants Program and funding additional community impact programs. Your support will provide the on going funds needed to continue this program which has infused over \$25,000 annually into the community.

By donating \$29.00 to the Community Building Fund, you will become a member. Members receive a "Community Savings Card" yielding discounts at many local, regional and national participating businesses. Enjoy the card as often as you would like for an entire year. Check the site often since new merchants are constantly being added and discounts do change periodically. You will find discounts of 10% to 50%, free items, 2 for 1 offers and more!

What types of projects will be funded?

Each year, a Small Grants Committee is formed by representatives from the inner North and Northeast Portland community to evaluate applications.

Funded projects include:

- **Blue Door Project**, a monthly service project to assist elderly, disabled, and single parents in single family households in the King Neighborhood.
- **The Portland Fruit Tree project** reaches out to residents in NE Portland to form neighborhood-based networks.
- **The Northeast Portland Tool Library** has a series of free workshops on home repair and improvement and gardening
- **Straightway Services Youth Program**. 120 kids learn to give back to their community through community service in a 12 week program.
- **Saturday with the Arts**. A multicultural outreach program that targets the under served youth living within the boundaries of NECN.

Who is NECN?

The Northeast Coalition of Neighborhoods, a 501c3 non-profit corporation, is dedicated to the livability of our inner North and Northeast neighborhoods serving as a district coalition representing twelve neighborhoods with over 60,000 households. Building livable communities since 1974.

The Neighborhood Clean-Up

Thank you to everyone who participated in the Grant Park Neighborhood Clean-Up on May 9th. There were over 90 households who participated in the event and we collected 9 tons of waste and 1.5 tons of yard debris! Thanks also to all of our fabulous volunteers including several students from Grant High School. And a special thanks to Northeast Conciliation of Neighborhoods for supporting the event through a reimbursement program.

Grant Park Land Use Update

A Type I (no public hearing) land use application was filed last spring with the City of Portland requesting a partition of the property located at 2208 NE 28th Avenue into three lots at 8,500 sq ft; 7,540 sq ft and 8,227 sq ft. Many neighbors objected to the application based on its impact to the neighborhood.

The GPNA entered a letter into the record requesting that the Bureau of Development Services (BDS) consider the concerns of the neighbors in making their decision. On July 6, a decision in the favor of the petitioner allowed the partition. Since then a group of neighbors has filed an intent to appeal, now pending.

Budget cuts at BDS

The Neighborhood Inspections Team (NIT) is losing funding for nuisance abatement, landlord trainings, and two Nuisance Inspectors. Nuisance abatement money has been used to clean up vacant, derelict and occupied properties. Lesser cases will probably simply be fined and liened, and the neighbors will have to put up with the eyesore. Response times on inspections will also be increased. Bad news for neighborhood livability.

TriMet Ends Program

TriMet, is facing \$30.5 million in budget cuts, and say they have no choice but to trim the \$472,770 Northeast Coalition of Neighborhoods "Rider Advocates" program contract for the upcoming fiscal year. However City Commissioner Dan Saltzman and NECN Executive Director Paige Coleman are looking for funding to keep these community-based mediation squads on the transit lines. The Rider Advocates have had an immeasurable impact on the lines because they help to interrupt or diffuse potential disruptions.

David Miller, lead Rider Advocate for the program, said he expects that TriMet's gains in elderly riders over the past couple of years will be erased and that some of the drivers will have problems with kids because school starts on Sept. 8 and after the 30th, advocates won't be there to mediate situations.

"We're not blaming TriMet for ending the program, they have to make the decisions that their finances allow," Coleman said.

In an open letter to TriMet General Manager Fred Hansen dated Aug. 14, Saltzman, North Precinct Commander Jim Ferraris and City Office of Youth Violence Prevention Director Rob Ingram joined to underscore what the city's Gang Violence Task Force believes to be a compelling need for the Rider Advocates' continued service.
